

**SUBJECT:** BID AWARD RECOMMENDATION-INMATE UNIFORMS, LINENS AND BEDDING

IT IS THE RECOMMENDATION OF THE TULSA COUNTY PURCHASING DEPARTMENT AND THE TULSA COUNTY SHERIFF'S OFFICE TO AWARD THE BID FOR INMATE UNIFORMS, LINENS AND BEDDING TO THE FOLLOWING VENDOR:

**BOB BARKER COMPANY, INC**

THIS BID IS THE OVERALL BEST BID RECEIVED ON A LINE BY LINES BASIS. ALTHOUGH UNIFORMS MANUFACTURING HAD LOW PRICING ON THEIR UNIFORMS, THEIR DELIVERY TIME FOR THE UNIFORMS WERE UP TO 30-45 DAYS. THE JAIL POPULATION FLUCTUATES FREQUENTLY AND THE SHERIFF'S OFFICE FELT THEY COULD NOT DELAY UP TO 45 DAYS TO RECEIVE THE UNIFORMS.

THIS BID IS GOOD FOR A ONE (1) YEAR PERIOD BEGINNING JUNE 14, 2016 THROUGH JUNE 13, 2017.

**Regarding:** Inmate Uniforms Linens and Bedding Bid

I received 8 bid sheets on 5-23-16 to evaluate for the Inmate Uniforms Linens and Bedding bid. The following are my findings:

- Uniforms Manufacturing Inc originally had **34** of the lowest bids (The highest number of low bids.) **They have numerous items that that they did not bid on and they have a 30-45 day shipping time for the inmate uniforms (This is what the majority of their low bids were on)** Because time is an important element and they do not have all items available we must consider an additional source.
- Bob Barker Company Inc originally had **13** of the lowest bids and were second behind Uniforms Manufacturing regarding inmate uniforms. They bid on all but one of the items and I believe we should consider them as the primary source for all of the items on this bid. (All of there items have a 5-14 day shipping lead time.)
- Charm-Tex had only **six** items that were lowest bid.  
(Not considered)
- ICS Jail Supplies had only **five** items that were lowest bid.  
(Not considered)
- Victory Supply had only **two** items that were lowest bid.  
(Not considered)
- ACME Supply Co Ltd had only **one** item that was lowest bid.  
(Not considered)
- Paradise Pillow Inc had only **one** item that was lowest bid.  
(Not considered)
- Club Tex Inc. Bid on one item and it was not the lowest.

Once again although Uniforms Manufacturing Inc had the highest number of low bids because of the amount of time to receive their products and they do not have all products available I recommend we award the Inmate Uniforms Linens and Bedding contract to Bob Barker Company Inc. Bob Barker had the lowest prices aside from Uniforms Manufacturing.
