SUBJECT: Resolution Amending the Tulsa County Building Code

We present for your approval the attached resolution amending the Tulsa County Building Code. The following changes are being proposed:

1. Designates the official Tulsa County Codes to be 2015 International Building Code, 2015 International Plumbing Code, 2015 International Fuel Gas Code, 2015 International Mechanical Code, 2015 International Residential Code, 2015 International Existing Building Code, 2015 International Fire Code and the 2014 National Electrical Code

All of the proposed changes would make the Tulsa County Code System compatible with the State of Oklahoma and the surrounding communities. The proposed effective date would be July 11, 2016. We would recommend approval.

WHEREAS, the Board of County Commissioners of Tulsa County, Oklahoma, first adopted the "BOCA Basic Building Code" on the 26th day of March, 1975 (CMF#87828) and,

WHEREAS, the Board of County Commissioners of Tulsa County, Oklahoma, on the 9th day of December, 1996, adopted the "BOCA National Building Code/1996", "The International Plumbing Code/1995", The International Mechanical Code/1996", "The National Electrical Code/1996" (CMF#162239) and,

WHEREAS, the Board of County Commissioners of Tulsa County, Oklahoma, last amended the Basic Building Permit Fees on the 17th day of March, 1997, (CMF#163284) and,

WHEREAS, the Board of County Commissioners of Tulsa County, Oklahoma, last amended the Electrical Fees on the 17th day of March, 1997 (CMF#163284) and,

WHEREAS, the Board of County Commissioners of Tulsa County, Oklahoma, last amended the Plumbing and Mechanical Fees on the 17th day of March, 1997, (CMF#163284) and,

WHEREAS, the Board of County Commissioners of Tulsa County, Oklahoma, last amended the International Codes and Fee schedule on the 28th day of June, 2004 (CMF#193713) and,

WHEREAS, it is the desire of the Board of County Commissioners of Tulsa County, Oklahoma, that the Building Code of Tulsa County include the latest design and construction criteria:

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, State of Oklahoma, that the said codes of Tulsa County be further amended as follows:

CHANGE: PERMITS: TO READ: Electrical, Mechanical, and Plumbing Permits shall only be issued to Oklahoma State Licensed Contractors, except plumbing permits may be issued to an individual who performs plumbing work on such individual's property of residence in accordance with the State of Oklahoma License Law of 1955 as amended July 25, 1997.

DELETE: Section 1824.10 HOUSE MOVING AREA RESTRICTION.

CHANGE: SECTION 1. ADOPTION OF BUILDING CODE: That certain documents being marked and designated as "The 2015 International Building Code, The 2015 International Plumbing Code, The 2015 International Fuel Gas Code, The 2015 International Mechanical Code, The 2015 International Residential Code, The 2015 International Existing Building Code, The 2015 International Fire Code and The 2014 National Electrical Code, be and are hereby adopted as the building codes of Tulsa County in the State of Oklahoma, and each and all of the regulations, provisions, penalties, conditions and terms of these codes are hereby referred to, adopted and made a part hereof as if fully set out in this Resolution with the addition, insertions, deletions, and changes, if any, prescribed in Section 2 of this Resolution.

CHANGE: SECTION 2. TO READ: Additions, insertions, deletions and changes to: "The 2015 International Building Code", "The 2015 Residential Code", "The 2015 International Plumbing Code", "The 2015 International Mechanical Code", "Annual Permit Fee Schedule", and Section 101.1 insert: "Tulsa County".

DELETE. SECTION 106.6.3 FEE REFUNDS of the 2015 International Plumbing Code.

DELETE. SECTION 106.5.3 FEE REFUNDS of the 2015 International Mechanical Code.

DELETE, SECTION R 313: AUTOMATIC FIRE SPRINKLER SYSTEM.

CHANGE: SECTION 310.1 EMERGENCY ESCAPE REQUIRED TO READ: Every habitable room above grade floor, except bathrooms, shall have at least one operable window or exterior door approved for emergency escape or rescue.....window shall have a minimum net clear opening of 5.7 square feet (0.530m2).
